Drinking Water Quality & Wastewater Annual Report - Consumer Confidence Report (CCR)

The Town of Blowing Rock has released the 2019 Drinking Water Quality Report and the 2019 System Performance Annual Report for the Collection System and Wastewater Treatment Plant. Important Note to Commercial Utility Customers

As a result of the pandemic, you may have temporarily closed your business, church or school building. Water that is held unused in pipes while the buildings are closed can become stagnant and produce undesirable tastes or odors when the building is reopened and water use is returned to normal.

To avoid these problems, it is recommended that the building plumbing, including water heaters, be thoroughly flushed before reopening for normal use. Thorough flushing includes operating all sink, tub, shower and toilet fixtures. Safety equipment, such as eye washes, safety showers and fire sprinkler systems may also require assessment and necessary maintenance. Water features inside buildings, hot tubs/spas and cooling towers also can require attention. The Center for Disease Control (CDC) has very detailed information on reactivating plumbing systems after dormant conditions on its website at the following link: https://www.cdc.gov/coronavirus/2019-ncov/php/building-water-system.html.

In addition, if your water is chlorinated, verify that a satisfactory chlorine residual is present throughout the plumbing system, after flushing, by checking for a residual at multiple fixtures and especially at the farthest end of the plumbing system.

As a final water quality check, you may consider collecting of a special noncompliance bacteriological sample or samples to ensure that bacteria is not present.
