Town of Blowing Rock Tourism Development Authority June 1, 2021

The Blowing Rock Tourism Development Authority (TDA) met on Tuesday, June 1, 2021, beginning at 3:30 p.m. The meeting was held at Town Hall, 1036 Main Street Blowing Rock, NC 28605. CALL TO ORDER

Chairman Bullis called the meeting to order at 3:30 p.m.

APPROVAL OF MINUTES

Member Gupton made a motion to approve the March 2, 2021, meeting minutes as written, seconded by Vice-Chair Walker. Unanimously approved.

Member Powell made a motion to approve the May 25, 2021, budget work session minutes as written, seconded by Member Gupton. Unanimously approved.

PUBLIC HEARING

FY 2020-2021 Proposed Budget

A Public Hearing was opened by Chairman Bullis, motion by Member Powell to receive comments regarding the FY 2020-2021 Recommended Budget originally presented to the Board for discussion during their May 25th work session, seconded by Member Gupton.

Chairman Bullis asked for questions or comments, with no comments or questions Member Tarbutton made a motion to close the Public Hearing, seconded by Member Powell. Unanimously approved.

NEW BUSINESS

FY 2020-2021 Budget Adoption

Member Tarbutton made a motion to approve the FY 2020-2021 Budget as presented, seconded by Member Gupton. Unanimously approved.

Financial Report – Occupancy Tax Proceeds Update

Ex-Offico Member Nicole Norman stated occupancy tax collections were up 61% compared to the April 2019 (Pre-COVID). She further stated FY to date collections were up 38%.

Ms. Norman also reviewed expenditures and stated projections are staying in line. With no questions or comments from the Board, Chairman Bullis thanked Ms. Norman for her update.

Budget Amendment

The Board reviewed the Budget Amendment of \$714,897 for an allocation if \$238,299 towards 1/3rd Funds Fund Balance and \$424,798 towards 2/3rd Funds Fund Balance and the remaining \$51,800 towards year end purchases requested by Executive Director Tracy Brown.

Member Gupton made a motion to approve the budget amendment as presented, seconded by Vice-Chair Walker. Unanimously approved. **Budget Amendment – Attachment A**
