## Financial Report – Occupancy Tax Proceeds Update

Ex-Offico Member Tasha Brown stated occupancy tax collections for January were up 13% compared to the last January (2023) and fiscal year to date collections were 81% of the budget amount. Ms. Brown also reviewed expenditures.

#### Wayfinding Signage

Ex-Offico Member Kevin Rothrock stated he is working on the final documents and the total package is around \$390,000. He further stated the work was good quality and will be built into the upcoming budget with an estimated completion date of the spring of 2025.

Director Brown advised a meeting had been held back in February in Marion, NC. Twenty (20) counties were in favor. Not all counties are fully on board, so it may take a few years to see any action. May have to hire someone to lobby for the different Town's looking to make the change to a 50/50 equation.

## • Fund Balance Review

Ms. Brown stated fund balance totals were \$2,170,087, \$183,000 is restricted and \$1,987,087 non-restricted.
