# Town of Blowing Rock **Tourism Development Authority** Minutes - April 7, 2015

The Town of Blowing Rock Tourism Development Authority met on Tuesday, April 7, 2015 at 3:30 p.m. in a budget work session held at Town Hall. Present were Authority Chairman Kent Tarbutton, Vice Chairman Rob Dyer and Members Dean Bullis, Lianne Mattar and Doug Matheson, Ex-officio members Scott Fogleman and Nicole Norman, and Executive Director Tracy Brown.

#### **CALL TO ORDER**

Chairman Kent Tarbutton called the meeting to order at 3:35 p.m.

#### APPROVAL OF MINUTES

Motion to approve the minutes from December 9, 2014 by Member Matheson, second by Member Dyer, Unanimously approved.

#### MONTHLY REPORTS

1. Financial Report

Ex-officio Member Nicole Norman began by reviewing fiscal year to date occupancy tax revenue through February 2015 collections. Ms. Norman stated collections for February were up 21.59% or \$7,578 compared to February 2014, while fiscal year to date collections are up 8.35% or \$48,441.24, compared to fiscal year 2014.

She then reviewed the Revenue and Expenditure Statements, indicating the financial statements were printed at the end of March or 75% into the fiscal year. Several line items were reviewed which had one time expenditures or seasonal factors affecting their budgetary progression. Attachment #1 - Financial Report

2. Operations Report

Executive Director Brown reviewed the previous quarter's (Jan.-March) operation activities via Power Point presentation:

- -Positive website indicators since platform changes

- -Promoting: WinterFest, Trout Derby, Valentines Stroll, Beer Month, Favorite Things, Romantic Getaways, etc.
- -Using new photography

- -7 Press releases (Holiday's, Winter in Blowing Rock, TDA End of Year Recap, WinterFest, Polar Plunge, Trout Derby, Beer Month & WineFestival - 28 confirmed placements
