SUBJECT: Muscari Annexation (156 Heather Ridge Lane)



Mr. and Mrs. John Muscari have filed a petition for annexation along with applicable fees and are requesting annexation of a single family lot at 156 Heather Ridge Lane. Mr. and Mrs. Muscari have purchased the property and are renovating the house. The property is currently on a septic system and Mr. and Mrs. Muscari would like to connect to the Town's sewer system. A manhole is located on nearby Heather Ridge Lane making a sewer tap and connection possible. The petitioners are responsible for the cost of extending the sewer line to their property. The property is currently in the ETJ and is zoned R-15, Single-family.

This property is currently served by public water. It is the Town's policy to require properties that desire public water or sewer to first be annexed into the Town limits. The front half of the subject property is within the Town limits and the rear half is in the ETJ. Consistent with Town policy, all of the subject property must be located within the corporate limits to be eligible for Town utility service.

Enclosed you will find a map, survey, and two resolutions to initiate the annexation process. If approved, a public hearing will be set for the November 9, 2016 Council meeting to consider annexation of the subject property.
