Enclosed please find a Budget Amendment Ordinance for the fiscal year 2015-2016 for your consideration.

Section 1 (General Fund) allocates a portion of revenues expected to exceed budget at the end of the year for Utility Franchise Tax towards pool restroom repair expenses (\$1,500) as approved at the April 12, 2016 Town Council meeting.

Section 2 (General Capital Projects Fund) allocates grant funds received from the Broyhill Family Foundation, Inc. (\$30,000) towards Broyhill improvement and maintenance projects.
