#### **BACKGROUND:**

Property belonging to Ms. Hilari Hutto had unpaid property taxes for 2009 and 2010. The Bank of Granite foreclosed on the property in February 2012 and the Town attempted to get the bank to pay the unpaid taxes. They remained unpaid. In 2012 RG Investments purchased the property. Before the closing, the Attorney's firm called to check on the status of property taxes and were told the account was current. It was not. Due to the clerical error that occurred in our office, staff feels like the release from the interest due on the account is justified. Please be advised the Town of Blowing Rock shows outstanding taxes due for the tax years 2009 and 2010, for parcel #2807974802000 located at 152 Sunset Dr., Blowing Rock NC. This property was formerly known as The Maple Lodge and is now Blowing Rock Ale House Restaurant. The amounts outstanding constitute a base tax amount of \$3,234.56 for each year with interest amounts being \$2,159.41 for 2009 and \$1,859.93 for 2010 for a total of \$10,488.46 for the two years.

Our office published notice of the uncollected taxes in the year they became delinquent and pursued collection from Ms. Hilari Hutto who owned the property when the taxes became delinquent, subsequently Ms. Hutto lost the property to Bank of Granite in 2011 due to bank foreclosure. The Town further perused the back taxes owed from the new owner of record once we became aware of the foreclosure by the Bank of Granite, but were not successful in receiving payment for these tax years.
