BACKGROUND:

In April 2015, Appalachian Ski Mountain led a community wide fundraising event for the Middle Fork Greenway. In one weekend, 49 Watauga County businesses raised \$45,000 for the Middle Fork Greenway development. This is incredible support and has elevated the greenway project in the community! Resolution No. 2017-10 A PROCLAMATION DECLARING JULY 2018 ROUND UP FOR THE MIDDLE FORK GREENWAY MONTH

WHEREAS, the Blowing Rock Town Council recognizes the initiative to connect Blowing Rock to Boone with a pedestrian and bicycle friendly greenway;

WHEREAS, communities in the High Country need safe access for people of all ages and abilities to recreate which is beneficial for promoting physical activity, lowers stress and improves emotional health;

WHEREAS, green corridors along the Middle Fork Greenway filter and buffer run-off to help stabilize the banks of a key tributary of the New River and water supply of the community;

WHEREAS, greenways provide economic value to communities as shown by studies of projects in the region such as the Virginia Creeper;

WHEREAS, Blue Ridge Conservancy and High Country Pathways are partnering with towns of Blowing Rock and Boone and Watauga County to seek state and federal grants which require matching funds;

NOW, THEREFORE, BE IT PROCLAIMED that the Town Council of Blowing Rock, North Carolina encourages all High Country businesses to participate in the July 2018 Round Up for the Middle Fork Greenway project to raise private funds to leverage government funding for the construction of the Middle Fork Greenway;

THEREFORE BE IT FURTHER PROCLAIMED that the Blowing Rock Town Council encourages every visitor and citizen patronizing Watauga County businesses to Round Up their bill to the nearest dollar to go toward the Middle Fork Greenway construction.
