Downtown Streetscape Phases 5 and 6



## Dear Mr. Fogleman:

As you know, Greene Construction, Inc., the contractor for the subject project, has proposed a change to the project scope, and has subsequently requested that an increase in contract amount

be approved for that change. The change consists of placing stone and concrete base under the cobble pavers between the sidewalk and curb, in lieu of stone base only. Both methods of construction are acceptable, and provide the same finished product look. The previous four (4) phases of the work along Main Street all used stone base under the pavers, without concrete.

Placing only a stone base allows the pavers to be more easily removed for any construction or maintenance of utilities

the contractor. The oldest area along Main Street was installed in 2009, from Martin House south to Chestnut, and has no visible problems.

Conversely, the use of concrete as a base for pavers has the exact opposite advantages and disadvantages. The concrete does provide a more stable base for pavers, to reduce the likelihood of settling. However, the concrete base does make access to underground

utilities in the area more difficult. Further, placing concrete for the base will provide a cleaner project during construction, yet only during the time between placing concrete sidewalk and paver installation, though this period of time is relatively short.

Greene Construction, Inc. submitted a proposal for this change in work which was reviewed by McGill Associates. Following our comments, a revised proposal was submitted, for a lump sum change order request amount of \$9,593.22. A copy of their proposal is enclosed for your information.
