Downtown Streetscape Phases 5 and 6

Dear Mr. Fogleman:

On February 2, 2016, three (3) bids were received and opened for the subject project. Greene Construction, Inc. was the lowest responsive, responsible bidder with a total bid amount of \$495,684.18 for the entire project, include the work on Main Street – Downtown Streetscape Phases 5 and 6 (Section 1), as well as sidewalk replacement long Laurel Lane (Section 2). Those individual section bids are \$382,922.77, and \$112,761.41 respectively.

While the total project is well within the previously estimated amount of \$588,480, we believe that the bid for Section 2 along Laurel Lane by itself is higher than would be expected. We recommend that some of the construction guidelines be altered, and the Laurel Lane portion be informally bid, for award at the March Town Council meeting.

Greene Construction, Inc. has successfully performed work on other Blowing Rock projects in the past. They are appropriately licensed with the North Carolina General Contractor Board, and appear to be capable of performing the work associated with this project. Therefore, we recommend that the Town of Blowing Rock award Section 1 of this project to Greene Construction, Inc. for the total amount of \$382,922.77. We further recommend that the Town include in the construction budget a ten-percent (10%) contingency.


