Attached please find for your consideration Resolution #2015-14, which declares equipment surplus and authorizes disposal.

Pursuant to N.C.G.S. 160A-270(c), Town Council is authorized to sell personal property by electronic auction upon adoption of a resolution authorizing an appropriate Town official to dispose of personal property belonging to the Town by public auction. Resolution #2015-14 authorizes the Town Manager or his designee to sell the property via electronic auction on [www.GovDeals.com](http://www.GovDeals.com).

Items to be sold include: an air cleaner from the American Legion building, a Pew from the American Legion building, 7 wooden chairs from the American Legion building, an exhaust fan from the American Legion building, bathroom fixtures from the old Visitor Center (includes a water fountain, urinal, 2 toilets and 3 sinks), an air conditioning unit from the old Visitor Center, 6 hanging lights from the Council chambers, a 1994 Chevrolet S10 pickup truck and a 2004 Ford F-150 pickup truck. All items are no longer in use.

GovDeals will be compensated at 7.5% of the total gross sale price for the sale through auction proceeds. The Town signed a contract with GovDeals.com on July 10, 2007 for disposal of surplus items utilizing the electronic auction method.

- 6 Hanging Lights with Brass Colored Chains, White Glass Fixtures with 100 Watt Capacity in Fair Condition

- 1 2004 Ford F-150 Pickup Truck VIN# 1FTPX14504NC06563 in Poor Condition

All sales will be processed through GovDeals and remitted to the Town net of auction fees. These items will be sold on an "as is" basis and all sales are final. The Town of Blowing Rock reserves the right to reject any and all bids.
