Enclosed please find a Budget Amendment Ordinance for the fiscal year 2015-2016 for your consideration.

Section 1 (General Fund) allocates funding as follows:

-Allocates a grant received from the Blowing Rock Community Foundation (\$3,000) to be used towards the purchase of a Golf Cart vehicle for use by the Police Department as well as pledged donations from the Village Foundation of Blowing Rock (\$2,500) and the Blowing Rock Community Library (\$500) to be used towards Winter White Lights in Town.

Section 2 (Water/Sewer Fund) allocates funding as follows:

-Brings funds previously allocated (March 10, 2015 Town Council Meeting) but unused at the end of Fiscal Year 2014-2015 from Fund Balance to be used towards remaining expenditures for the Dam Emergency Action Plan (\$2,185 remaining from the initially allocated total of \$9,500).

Be it ordained by the Board of Commissioners of the Town of Blowing Rock, North Carolina, that the following amendment be made to the annual budget ordinance for the fiscal year ending June 30, 2016:
