Attached please find for your consideration Resolution #2015-01, which declares equipment surplus and authorizes disposal.

Pursuant to N.C.G.S. 160A-270(c), Town Council is authorized to sell personal property by electronic auction upon adoption of a resolution authorizing an appropriate town official to dispose of personal property belonging to the town by public auction. Resolution #2015-01 authorizes the Town Manager or his designee to sell the property via electronic auction on www.GovDeals.com.

Items to be sold include 50 folding metal chairs, 25 stackable red cushioned chairs with metal frames, a 36 X 78 foot pool cover, a 2003 Chevrolet C-7500 truck and a 2000 Ford F-550 truck. All items are no longer in use.

GovDeals will be compensated at 7.5% of the total gross sale price for the sale through auction proceeds. The Town signed a contract with GovDeals.com on July 10, 2007 for disposal of surplus items utilizing the electronic auction method.

RESOLUTION DECLARING SURPLUS PROPERTY & AUTHORIZING DISPOSAL (Resolution #2015-01)
