Enclosed please find a Budget Amendment Ordinance for the fiscal year 2018-2019 for your consideration.

Section 1 (General Fund) is to allocate funds that were allocated from General Fund Balance last year back to Fund Balance as funds have arrived from the North Carolina Department of Public Safety related to the 2018 Rain Storm and road washout repairs (\$71,025). Town Council authorized the allocation of General Fund Balance to pay for such repairs in FY 2017-18 having not received official notification funds would be provided for this event, but recognizing the need for the repairs immediately. Since that time, funds were received from NC Department of Public Safety, thereby allowing the funds previously allocated to be returned to Fund Balance.

This section also allocates future lien proceeds for the demolition of the Miller property located at 712 Possum Hollow Rd. (\$17,160). As clarification, demolition lien proceeds are not received until the property the dwelling was located on sells or is foreclosed on. This may be sometime from now. As a result, the allocation of future proceeds will in effect lower the Town's unassigned or unallocated fund balance, as it will remain a receivable until such funds are eventually collected.

Finally, this section also allocates funds towards the purchase and maintenance of memorial benches in memorial park, funded via donations to the Tree/Bench Reserve fund (\$3,500).

Section 2 (General Capital Fund) transfers funding back to the General Fund Balance as described above related to the 2018 Rain Storm road repairs and NC Department of Public Safety funds received.

This section also allocates Tree and Bench Donations received towards the maintenance and purchase of trees in the Town as well as memorial bench purchases and maintenance (\$3,500 towards memorial bench purchases and maintenance and \$7,640 towards the tree maintenance/purchase fund).

Finally, this section also adjusts the Middle Fork Greenway DWR Grant Funds to recognize the match required, which will be funded via reimbursement to the Town from the Blue Ridge Conservancy (\$55,000).
