Mayor Lawrence and Commissioner Matheson Re-elected to Town Council, Yount Reappointed Mayor Pro-tem:







Town Receives Official FEMA and NC Project Qualification Notice for Wonderland Trail and Quail Hollow Road Repairs

The Federal Emergency Management Association (FEMA) and NC Department of Public Safety have informed the Town that these road repairs will qualify for reimbursement.

The current schedule for the projects is anticipated to be as follows:

Bids to be awarded at the February 11, 2014 Council meeting

Construction to begin March, 2014

Construction to be complete July, 2014

In anticipation of formal approval, the Town of Blowing Rock Board of Commissioners approved project appropriations of \$270,000 for Wonderland Trail and \$70,000 for Quail Hollow at the November 12, 2013 council meeting.
