

PROJECT UPDATES

Wastewater Treatment Plant Improvements



Greene Construction, Inc. continues work on the Wastewater Treatment Plant Improvements Project. The project is approximately 90% complete, with Basin #4, #3, and #2 complete, Basin #1 work nearing completion and handrail hardware installation continu-

ing. Generator delivery is excepted next week. The project has a scheduled completion date of March 25, 2013.

The Comprehensive Plan Public Opinion Survey

The Comprehensive Plan Public Opinion Survey was conducted in October. NC State University's Center for Urban Affairs is finalizing the survey summary and will provide copies for Council review at the annual retreat in January. Visioning workshops are tentatively planned for April-May 2013.

Highway 321 Widening Project

Blasting and grading operations continue at Cliff Dwellers and the new proposed intersection of Main Street and Hwy 321 near Chetola Dam. There will be no blasting in this area again until January 3, 2013. Expect regular road closures in this immediate area on Tuesdays and Thursdays from 11 am to 3 pm. Police Department Roofing

Roof alterations were recently completed at the Police Department to correct a leak problem. The work was performed by Blowing Rock Property Services.

PROJECT UPDATES CONTINUED

Streetscape Phase III

Mountain Crest Construction completed Phase III of the Downtown Streetscape project on Main Street. New curb and gutter, pavers, and sidewalk were installed from just north of Storie Street to the south end of St. Mary's Episcopal Church. Two street trees and tree grates were also added with the project.

NCDOT has completed all paving and re-striping of Main Street from the Hwy 221 intersection to the south end of Main Street at Broyhill Furniture.

Greene Construction is in the process of finishing a new Salt Bin at the Town Public Works warehouse site.



HAVE YOU PAID YOUR 2012 PROPERTY TAXES?

To those who have not paid their 2012 Town of Blowing Rock property taxes, the last date before interest accrues is January 5, 2013. If you pay by mail your payment must be postmarked on or before January 5, 2013 to avoid interest penalty. GO GREEN! ELECTRONIC BILLING

You may have noticed on this month's water/sewer bill a notice that the Town is now offering an electronic billing option. This service is optional and will only go into effect on your account if you register for the service. The Town has partnered with SouthData Innovative Solutions in order to offer this paperless billing option. If a customer registers for the service they may have the option to no longer receive their bill through U.S. Mail, but rather receive their bill via email or to be e-mailed a bill in addition to receiving their paper bill. This option will offer customers quicker access to their bills and a way to store billing history electronically as well as reduce mail and clutter.
